# **Agenda Item 4: Public Presentation**

### Agenda Item 5: Activity Update

5.1 SW presented an overview of the skills "bootcamp" programme being promoted by DfE. Crucial to the success of a programme will be the recruitment of sufficient trainees, which requires support from

employers. The training is across a range of subject matter areas, including digital, typically at a Level 3-5 standard (A-Level, 1<sup>st</sup> Year Degree), and requires 60 hours of training per individual over a period up to 16 weeks. Training is available at no cost to the unemployed, with a 90% discount to SME employees, and a 70% discount for employees of larger firms. Payment is dependent upon milestones being reached, including 5 days completed training, completion of the course and importantly demonstration that the new skills are being applied or that an employment interview has been conducted. The LEP is expected to submit a bid by mid-February, but greater understanding will ultimately be needed of the requirements necessary to run the programme, attrition rates, and risks more generally. Assuming a programme can be commissioned, it is likely that the bulk of the training will occur in the Autumn.

SW was asked to share the slides (since done) and sub-board members were asked to raise awareness through their networks and promote the programme to specific employers who might be willing to commit to training opportunities.

- 5.2 ND said she had spoken to Joe Baker at Astra Zeneca and would pass on details.
- 5.3 IB presented a summary of ongoing work that had taken place since the last meeting. CJ, who chairs Connecting Cheshire, was able to provide considerable additional information regarding the relationship with BDUK and its programmes and some of the challenges faced in delivering the digital ambitions of the sub-region. BD UK is expected to commission a market assessment in Summer 2022 which, will establish a refreshed baseline of connectivity, which will then be kept current by quarterly updates. CJ also mentioned that the existing Airband Contract, to connect rural properties, had been increased with the opportunity to reach another 2000 properties.
- 5.4 CJ agreed that a joint meeting between the DCB and Connecting Cheshire would be advantageous and will propose some dates to IB. Matters to be discussed might include ideas for inclusion in a possible county deal, how the two boards maximise their support of each other and minimise duplication and ensure that communities and people don't get "left behind" for lack of infrastructure (incl. switching from copper cable to VOIP telephony), skills or lack or affordability of devices and connections.
