Agenda Item 1: Welcome, Introductions & Apologies

The Chair welcomed members to the meeting.

Apologies were received from Charlie Seward (represented by Lisa Harris), Frank Jordan and Peter Skates.

Agenda Item 2: Declarations of Interest

Robert Davis declared a pecuniary interest in Agenda Item 6. The Committee agreed that as no financial decisions were involved in relation to this Agenda Item, that it would be appropriate for Mr Davis to remain and contribute to the discussion.

Agenda Item 3: Minutes of Previous Meeting and Matters Arising

The Committee approved the Minutes of the meeting held on Friday 7th February 2020. All actions were completed. There were no matters arising.

Agenda Item 4: Public Speaking Time

Due to the exceptional circumstances the public speaking / open session was not offered at this meeting. It was noted that public queries on the papers could be submitted for consideration in writing.

Agenda Item 5: Covid-19 Responding to the Crisis and Developing a Recovery Strategy

The Committee reflected on the current known impacts of Covid-19 / Coronavirus on the national and local economy. This meeting provided an opportunity for the Strategy Committee to respond to the Board invitation for sub-committees to discuss how the LEP might respond in minimising the impacts of the crisis and importantly start the process of planning for recovery. A summary of the ideas discussed, for consideration at the next Board are attached as an appendix to the minutes (Appendix A).

Updates on the current response were provided by Lisa Harris and Steve Park on behalf of Cheshire West and Chester Council and Warrington Borough Council respectively. Philip Cox provided a further update on the work that the LEP's Growth Hub is undertaking to support businesses at this incredibly difficult time. It was confirmed that as part of the resilience and recovery activity the LEP was to lead a sub-regional 'Economic Resilience Cell' comprising initially the LEP, local authorities, business representation, BEIS, Job Centre Plus and Cheshire Constabulary (though final membership of the group is still currently being worked out).

Intelligence was also shared by the private sector members of the committee. Different sectors are being impacted to varying degrees, with the construction centre cited as one example that is trying to maintain a degree of business as usual through adopting a more flexible approach to contracting and project mobilisation. It was reported that disruption to supply chains was one constraint to continued operations including the ability to source spare parts for vehicles and machinery.

Committee members stressed the importance of getting reliable, easy to follow information to business so that they can understand and respond to the various support available to them. The LEP has funded a mailshot to every business on the local authority business rates database

The Committee discussed the paper circulated by the Head of Policy and Strategy. As well as highlighting some of the known impacts on the local economy and workforce, the paper provided a summary of known government and local support on offer to businesses at this time. It was highlighted that a significant proportion (around 25%) of the sub-regional workforce is employed in 'vulnerable' sectors.

In terms of how the strategy programme might flex to support the response, and thoughts on planning for recovery, the key points raised were as follows: -

- Consider how to position LEP support to 'phoenix' businesses, i.e. those who are forced to close
 a business down as a result of CV19 but who have viable ideas for new businesses. Could also
 link into provision of new or expanded incubator facilities with associated business support and
 networks. Example of the BioHub at Alderley Park was given in terms of targeted support in the
 right environment.
- Making use of existing LEP resources such as Growing Places Fund. Committee considers that
 one of the greater times of risk for business will be in exiting the current slow down at the start
 of the recovery phase. Recommending some options be developed as to how GPF might be
 deployed as either grant or loan to aid this recovery and to support business currently who have
 an opportunity to diversify.
- Consider whether a different or more flexible approach to rolling out the Accelerate programme could be adopted. Current situation is driving behaviour change in terms of adopting digital technologies so this would be an ideal time to be offering training in digital skills but recognise cash constraints might make a 60% employer contribution unviable.
- Review and re-frame the draft Local Industrial Strategy so that it contains action to support the recovery

APPENDIX A - NOTE TO LEP BOARD ON STRATEGY COMMITTEE RESPONSE TO COVID-19 CRISIS

Background

- The Strategy Committee met virtually on Friday 3rd April 2020. The principle item for discussion on the agenda was the invitation by the LEP Board for sub-committees to meet to discuss how their programmes could be adjusted to respond to the immediate impact of the crisis, including reprioritising or re-directing funding, and to begin debating and planning for recovery;
- This note summarises the key points of the Strategy Committee discussion.

Key areas of discussion

- Communication importance of ongoing, clear communication with business
- economic resilience cell noted that one has been established, led by the LEP
- options re support for businesses that fall between current national support programmes
- impact of changing behaviours on future economic activity and investment
- importance of improving access to skills and training up to 1/3 of under-25s at risk of unemployment
- Logistics remaining critical sector but might accelerate adoption of digitisation
- Implications for public transport effect of reduced car travel and link to better air quality
- LIS fundamentals are still right; some sectors could emerge stronger (e.g. energy & clean growth and life sciences)

Suggested response actions
